1. First order of business was to elect the Fundraiser Coordinator to the Board for the 2010 Season:

2. Nathan let Board know that the Jersey's would be purchased from Nike this year and the order had to be in by May 5, 2010. They will be tackle twill Jersey's.
3. Because of this deadline, the first round of open registration will be from April 1-May 1, 2010
4. Nathan went over the Registration Flyer for Gresham/Barlow School District, it will be a joint flyer that the School District will send out to the Elementary & Middle Schools. Discussed the information that Barlow will have printed on the flyer such as registration dates, website to register, fees, etc.

5. Discussed the Coaches Code of Conduct and requirements, this was a limited discussion.
6. Discussed Parents Code of Conduct and that they need to sign off that they have read the TVYFL by laws so they understand how the program works. Also, there could be a discussion about this at parents night.
7. Nathan suggested a pre-registration night when interested kids and their parents could come and watch a video at Barlow High School to have a better understanding of the Barlow Youth Football League program.
8. Discussed videotaping and picture taking at games. It was discussed that videotaping and pictures taken could only be done off the field, on the track and could not use the Press Box. Pictures and videotapes cannot be sold for profit.
9. Fee Schedule:
 - a. April 1, 2010 – May 1, 2010 = \$250.00
 - b. May 2, 2010 - June 1, 2010 = \$265.00
 - c. June 2, 2010 – August 1, 2010 = \$280.00

10. Refund Policy:

\$25.00 processing fee on all refunds, 100% refund if we cannot accept registration. 100% less processing fee up to June 30, 50% refund up to the last day of camp, 0% refund thereafter. There will be a \$ 25.00 fee on all returned checks.

11. Voted to have a Blackout date when all games would be played away, with the following Saturday to be the Homecoming games week.
12. Discussed having equity between teams as far as Trophy's, Season End Party, etc. Volunteer Coordinator Julie Grantz will organize a "Team Mom" night.
